1. CONFIRMATION OF BOOKINGS

1.1 - A booking is only confirmed when a booking confirmation is issued by the company either by electronic means or by post. Acceptance of your booking confirmation constitutes your agreement to these terms and conditions.

2. PAYMENTS & CHARGES

2.1 - Places can only be guaranteed with a deposit payment of £10.00 per person (Can be Cash, Card). The deposit is non-refundable.

2.2 - Full payment will be required no later than 14 days before the event date. Failure to pay within this time may result in the cancellation of the booking and the forfeiture of any deposit paid. An invoice for this will be sent via email to you 30 days before your party for your contracted numbers.

2.4 - A 12.5 % service charge will automatically be added to parties over 6 people.

2.5 - If numbers should rise following this payment, The Waterfront will try to accommodate the additional guests but this will be at the company's discretion.

2.6 You will be allotted a 2 hour slot for your table, unless otherwise agreed

2.7 - If numbers should reduce after full payment is made no refunds shall be made.

2.8 - The Client agrees to pay all charges on the due date. If there are queries on any part of an invoice, the Client will pay the undisputed balance of the sum owing on the date due and the remainder on resolution of the query.
